<u>Comment</u>: The complete genome of *E. coli*, strain 4.0522 was sequenced at the <u>J. Craig Venter Institute</u> (GenBank: AEZU00000000).

E. coli is a Gram-negative rod-shaped bacterium which occurs singly or in pairs. It is a major facultative inhabitant of the large intestine.

E. coli, strain 4.0522 is referred to as a non-O157, Shiga toxin-producing *E. coli* (STEC) strain. ^{1,2} STEC bacteria can cause diarrhea in humans and several STEC serotypes have been frequently associated with severe human disease, such as hemorrhagic colitis and hemolytic uremic syndrome. The *E. coli* 4.0522 genome encodes for both Shiga-like type I toxin (Stx1) and Shiga-like type II toxin (Stx2). ^{1,2}

Material Provided:

Each vial contains approximately 0.5 mL of bacterial culture in Tryptic Soy broth supplemented with 10% glycerol.

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

NR-17627 was packaged aseptically, in screw-capped plastic cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Growth Conditions:

Media:

Tryptic Soy broth or equivalent

Tryptic Soy agar with 5% sheep blood or equivalent

Incubation:

Temperature: 37°C Atmosphere: Aerobic

Propagation:

- 1. Keep vial frozen until ready for use, then thaw.
- Transfer the entire thawed aliquot into a single tube of broth.
- Use several drops of the suspension to inoculate an agar slant and/or plate.
- 4. Incubate the tube, slant and/or plate at 37°C for 24 hours
