Bacteria Classification: *Alcaligenaceae, Bordetella*

Species: *Bordetella holmesii*

Strain: H785 (also referred to as CDC-H785-BH)

Original Source: *Bordetella holmesii* (*B. holmesii*), strain H785 was isolated in 2011 from respiratory fluid of a patient with pertussis-like symptoms in Oregon, USA.¹

Comments: The complete genome of *B. holmesii*, strain H785 has been sequenced (GenBank: [JGWB00000000](https://www.ncbi.nlm.nih.gov/nuccore/JGWB00000000)).¹

B. holmesii is a Gram-negative, fastidious, non-motile coccobacilli that produces a brown soluble pigment and is closely related to *Bordetella pertussis*.²⁻⁴ It is an emerging opportunistic pathogen that has been linked to invasive infections among immunocompromised patients, particularly those lacking splenic function. In healthy individuals, it can cause respiratory disease, including a pertussis-like illness.³⁻⁵

Material Provided:

Each vial contains approximately 0.5 mL of bacterial culture in Tryptic Soy broth supplemented with 10% glycerol.

Note: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

NR-44175 was packaged aseptically in cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Growth Conditions:

Media:

Tryptic Soy broth or Brain Heart Infusion broth or Bordet Gengou broth or equivalent

Tryptic Soy agar with 5% defibrinated sheep blood or Brain Heart Infusion agar or Bordet Gengou agar or equivalent

Incubation:

Temperature: 37°C

Atmosphere: Aerobic with or without 5% CO₂

Propagation:

1. Keep vial frozen until ready for use, then thaw.
2. Transfer the entire thawed aliquot into a single tube of broth.
3. Use several drops of the suspension to inoculate an agar slant and/or plate.
4. Incubate the tube, slant and/or plate at 37°C for 2 to 7 days.
