### **Product Description:**

NR-12214 is a mobilizable replicative plasmid, pMo168, for allelic exchange in *Burkholderia* species (GenBank: <u>EU862244</u>). Plasmid pMo168 was deposited cloned into host *Escherichia coli* (*E. coli*) JM109 cells with no insert. After transformation into a commercially available chemically competent strain of *E. coli*, pMo168 was extracted using a QIAGEN<sup>®</sup> Plasmid Mega Kit.

Note: Sequencing results revealed that all significant elements of the vector described in the literature are present in NR-12214. The resulting size of the plasmid is 7.111 kilobases. The plasmid map and the complete plasmid sequence are provided on the Certificate of Analysis for NR-12214.

### **Material Provided:**

Each vial of NR-12214 contains approximately 1  $\mu g$  of plasmid DNA in TE buffer. The concentration is shown on the Certificate of Analysis.

## Packaging/Storage:

NR-12214 was packaged aseptically in plastic cryovials. The product is provided frozen on dry ice and should be stored at -20°C or colder immediately upon arrival. Freeze-thaw cycles should be minimized.

## **Post-Transformation Growth Conditions:**

Media

NR-12214 contains the gene required for kanamycin (Kan) resistance. The recommended concentration of Kan in culture is  $50 \mu g/mL$ .

Incubation:

Temperature: 37°C Atmosphere: Aerobic

Propagation:

Incubate the tube, slant and/or plate at 37°C for 24 hours.
