Reagent: NR-42566 is a preparation of late-immune sera from a non-human primate (NHP) that was immunized by subcutaneous injection of 10⁵ plaque-forming units of live Japanese encephalitis virus (JEV), SA 14-14-2. The animal remained seronegative and was re-challenged with JEV on day 120. Sera were collected at approximately 30-day intervals from day 180 through day 390, and then pooled.

Material Provided:

Each vial contains approximately 200 µL of late-immune Japanese encephalitis virus antisera.

Packaging/Storage:

NR-42566 was packaged in screw-capped plastic cryovials. The product is provided frozen and should be stored at -70°C or colder immediately upon arrival.
