- <u>Comments</u>: *A. arabiensis*, strain KGB was generously donated to CDC by Maureen Coetzee. According to the donor, the KGB strain may contain a form of inversion 3Ra that also includes a lethal.<sup>1</sup>
- <u>Applications</u>: MRA-339K is suitable for DNA and RNA isolation, protein extraction, etc.

The most recent morphological authentication was performed on the F5 generation of *A. arabiensis*, strain KGB.

### **Material Provided:**

Each kit of MRA-339K contains 10 adult male and 10 adult female wild-type *A. arabiensis*, strain KGB mosquitoes, which were preserved in liquid nitrogen (quick-frozen) while alive. MRA-339K lot 3603287 is generation F38 of *A. arabiensis*, strain KGB.

### Packaging/Storage:

MRA-339K is prepared and shipped from CDC, Atlanta, GA USA. The product is provided frozen and should be stored at -80°C or colder immediately upon arrival.
