<sup>&</sup>lt;sup>4</sup>The Tissue Culture Infectious Dose 50% (TCID<sub>50</sub>) is the 50% infectious endpoint in cell culture. The TCID<sub>50</sub> is the dilution of virus that under the conditions of the assay can be expected to infect 50% of the culture vessels inoculated, just as a Lethal Dose 50% (LD<sub>50</sub>) is expected to kill half of the animals exposed. A reciprocal of the dilution required to yield the TCID<sub>50</sub> provides a measure of the titer (or infectivity) of a virus preparation. <sup>5</sup>7 days at 37°C with 5% CO<sub>2</sub>
