Product Description:

Antiserum to membrane protein 0397 of *Toxoplasma gondii* was produced by intradermal immunization of a female three month old New Zealand white rabbit with two membrane protein 0397 peptides conjugated to keyhole limpet hemocyanin (KLH).

Material Provided:

NR-4518 is distributed as a three vial kit. The kit contains pre-bleed (NRC-1226), first bleed (NRC-1227) and second bleed (NRC-1228) rabbit polyclonal antiserum. Each vial contains approximately 0.15 mL (pre-bleed) or 0.650 mL (first and second bleed) of rabbit polyclonal antiserum.
