Product Description:

Antiserum to COWP5 of *Cryptosporidium parvum* was produced by intradermal immunization of a three month old rabbit with three COWP5 peptides conjugated to keyhole limpet hemocyanin (KLH).

Material Provided:

NR-9600 is distributed as a three vial kit. The kit contains pre-bleed (NRC-1867), first bleed (NRC-1868) and second bleed (NRC-1869) rabbit polyclonal antiserum. Each vial contains approximately 0.13 mL (pre-bleed), 0.38 mL (first bleed) and 0.38 mL (second bleed) of rabbit polyclonal antiserum.

NR-9600 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -20°C or colder immediately upon arrival.

NR-9600 is reactive with COWP5 of *Cryptosporidium parvum* by ELISA and immunofluorescence analysis as communicated by the contributor.
