Genomic RNA was isolated from a preparation of cell lysate and supernatant from *Cercopithecus aethiops* kidney epithelial cells (Vero cells, clone E6) infected with Zika virus (ZIKV), R103451. The complete genomic sequence of BEI Resources ZIKV, R103451 (NR-50355, Lot No. 64362036) has been determined (GenBank: KX262887).¹

NR-50358 has been qualified for PCR applications by amplification of an approximately 1100 nucleotide sequence. Recommended dilutions for successful RT-PCR amplification are indicated on the Certificate of Analysis for each lot.

Material Provided:

Each vial contains 100 μ L of viral genomic RNA in TE buffer (10 mM Tris-HCl, 1 mM EDTA, pH 7.0). The viral genomic RNA is in a background of cellular nucleic acid and carrier RNA. The vial should be centrifuged prior to opening.

Packaging/Storage:

NR-50358 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen on dry ice and should be stored at -60°C or colder immediately upon arrival. Freeze-thaw cycles should be minimized.
