<u>Comments</u>: *E. faecium*, strain ERV165 (<u>HMP ID 1364</u>) is reported to be resistant to vancomycin.^{1,3} *E. faecium*, strain ERV165 is a reference genome for <u>The Human Microbiome Project</u> (HMP). HMP is an initiative to identify and characterize human microbial flora. The complete genome of *E. faecium*, strain ERV165 was sequenced by the Genome Institute at <u>Washington University</u> (GenBank: <u>AMAV000000000</u>).

Note: HMP material is taxonomically classified by the depositor. Quality control of these materials is only performed to demonstrate that the material distributed by BEI Resources is identical to the deposited material.

E. faecium is a Gram-positive, facultative anaerobic coccus that is a commensal inhabitant of the gastrointestinal tract of both humans and animals.^{4,5} *E. faecium* is an emerging and challenging nosocomial pathogen due to its inherent hardiness and ability to develop antibiotic resistance.⁵

Material Provided:

Each vial contains approximately 0.5 mL of bacterial culture in Brain Heart Infusion broth supplemented with 10% glycerol.

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

HM-970 was packaged aseptically in cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Media:

Tryptic Soy broth or Brain Heart Infusion broth or equivalent Tryptic Soy agar or Tryptic Soy agar with 5% defibrinated sheep blood or Brain Heart Infusion agar or equivalent Incubation:

Temperature: 37°C

Atmosphere: Aerobic or anaerobic

Propagation:

- 1. Keep vial frozen until ready for use, then thaw.
- Transfer the entire thawed aliquot into a single tube of broth.
- Use several drops of the suspension to inoculate an agar slant and/or plate.
- 4. Incubate tube, slant and/or plate for 1 day.
