Product Description:

Genomic DNA was obtained from a preparation of *Salmonella enterica* (*S. enterica*) subsp. *enterica* serovar Thompson that was isolated from the stool of a patient with diarrhea during the 2004 *Salmonella* outbreak in Pennsylvania.^{1,2}

S. enterica subsp. *enterica* serovar Thompson is found in domestic and wild animals and is generally spread to humans via consumption of contaminated water or food resulting in gastroenteritis.

NR-4607 has been qualified for PCR applications by amplification of approximately 1500 bp of the 16S ribosomal RNA.

Material Provided:

Each vial contains 4 to 6 μ g of bacterial genomic DNA in TE buffer (10 mM Tris-HCl and 1 mM EDTA, pH 7.4). The concentration is shown on the Certificate of Analysis. The vial should be centrifuged prior to opening.

Packaging/Storage:

NR-4607 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen on dry ice and should be stored at -20°C or colder immediately upon arrival. Freeze-thaw cycles should be minimized.
