<u>Original Source</u>: *Prevotella* sp., strain S7-1-8 is a vaginal isolate obtained in 2012 from a woman with bacterial vaginosis in Washington, USA.^{1,2}

<u>Comments</u>: Prevotella sp., strain S7-1-8 (<u>HMP ID 1640</u>) is a reference genome for <u>The Human Microbiome Project</u> (HMP). HMP is an initiative to identify and characterize human microbial flora. The complete genome of *Prevotella* sp., strain S7-1-8 was sequenced at the <u>J. Craig Venter Institute</u> (GenBank: JRNC00000000).

Note: HMP material is taxonomically classified by the depositor. Quality control of these materials is only performed to demonstrate that the material distributed by BEI Resources is identical to the deposited material.

Prevotella species are generally Gram-negative, obligately anaerobic, non-motile, non-sporulating, rod-shaped bacteria usually found in the oral, upper respiratory and urogenital flora of mammals.^{3,4} Some *Prevotella* species may cause serious (usually polymicrobial) infections and periodontal disease.⁴

Material Provided:

Each vial contains approximately 0.5 mL of bacterial culture in Modified Chopped Meat broth supplemented with 10% glycerol.

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

HM-1103 was packaged aseptically in cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Growth Conditions:

Media:

Modified Chopped Meat broth or equivalent

Tryptic Soy agar with 5% defibrinated sheep blood or equivalent

Incubation:

Temperature: 37°C Atmosphere: Anaerobic

Propagation:

- 1. Keep vial frozen until ready for use, then thaw.
- Transfer the entire thawed aliquot into a single tube of broth.
- 3. Use several drops of the suspension to inoculate an agar slant and/or plate.
- Incubate the tube, slant and/or plate at 37°C for 1 to 3 days.
