Product Description:

Genomic DNA was isolated from a preparation of *Clostridium botulinum* (*C. botulinum*), Strain Walls 8G (VPI 4404, BL 4851), serotype F (proteolytic).

C. botulinum, strain Walls 8G was isolated from a crab obtained from the York River in Virginia, USA.¹ This strain is a BoNT type F (proteolytic) toxin-producing strain and can cause illness in humans. The complete genome sequence of C. botulinum, strain Walls 8G has been determined (GenBank: LBFH00000000).

NR-2713 has been qualified for PCR applications by amplification of approximately 1500 base pairs of the 16S ribosomal RNA gene.

Material Provided:

Each vial of NR-2713 contains bacterial genomic DNA in buffer. The concentration is shown on the Certificate of Analysis. The vial should be centrifuged prior to opening.

Packaging/Storage:

NR-2713 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen on dry ice and should be stored at -20°C or colder immediately upon arrival. Freeze-thaw cycles should be minimized.
