7. HANDLING AND STORAGE

Precautions for safe handling

Advice on Safe Handling Use aseptic procedures. Decontamination of work surfaces daily, after finishing work and following spills (Solutions of sodium hypochlorite 0.1% or sodium hydroxide 0.1 N readily inactivate the toxin). Standard microbiological practices should be followed. Do not get in eyes, on skin or on clothing. Do not breathe vapors or mist. Use good personal hygiene practices. Eating, drinking and smoking in work areas is prohibited. Remove contaminated clothing and protective equipment before entering eating areas. Eyewash stations and showers should be available in areas where this material is used and stored. Access to the laboratory is restricted when work is being conducted. A biohazard sign with relevant information should be posted at the entrance. "Toxins in Use - Authorized Personnel Only" should be clearly posted. Frequent and careful hand-washing and laboratory decontamination should be strictly enforced.
