Material Provided:

Each vial contains approximately 1 mL of pooled allantoic fluid from specific-pathogen free (SPF) embryonated chicken eggs infected with reassortant influenza A virus, A/Tokyo/1/75 (HA, NA) x A/Puerto Rico/8/34 (H3N2).

Packaging/Storage:

NR-3629 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -70°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Growth Conditions:

Host: 9 to 11-day-old SPF embryonated chicken eggs

Infection: Embryonated chicken eggs must be candled for viability prior to inoculation

Incubation: 1 to 3 days at 33 to 35°C in a humidified chamber without CO₂

Effect: Hemagglutination activity using chicken red blood cells and allantoic fluid from infected embryonated chicken eggs
