Original Source: *Escherichia coli* (*E. coli*), strain Ec1643, was isolated from the bloodstream of a patient with septicemia.

Comments: *E. coli*, strain Ec1643 is a host bacterium for phi05_2388UV, a temperate phage.¹ The complete genome of bacteriophage phi05_2388UV/Ec1643 is currently being sequenced at the [J. Craig Venter Institute](http://www.jcvi.org).

E. coli is a Gram-negative, rod-shaped bacterium commonly found in the gut flora of warm-blooded animals and is the primary facultative anaerobe of the human gastrointestinal tract. While most *E. coli* strains are harmless and are an important part of a healthy intestinal tract, some serotypes are pathogenic, causing diarrhea, urinary tract infections, respiratory illness, pneumonia, or other illnesses in their host.²⁻⁴

Material Provided:

Each vial contains approximately 0.5 mL of bacterial culture in Tryptic Soy broth supplemented with 10% glycerol.

Note: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

NR-51342 was packaged aseptically, in screw-capped plastic cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Growth Conditions:

Media:

Tryptic Soy broth or equivalent

Tryptic Soy agar or Tryptic Soy agar with 5% defibrinated sheep blood or equivalent

Incubation:

Temperature: 37°C

Atmosphere: Aerobic

Propagation:

1. Keep vial frozen until ready for use, then thaw.
2. Transfer the entire thawed aliquot into a single tube of broth.

3. Use several drops of the suspension to inoculate an agar slant and/or plate.
4. Incubate the tube, slant and/or plate at 37°C for 1 day.
