Genomic DNA was extracted from a preparation of *Mycobacterium canettii (M. canettii)*, strain NLA000701671.

Mycobacterium canettii (M. canettii), strain NLA000701671 was isolated in October 2007 from human sputum in the Netherlands.¹

NR-49660 has been qualified for PCR applications by amplification of approximately 1500 base pairs of the 16S ribosomal RNA gene.

Material Provided:

Each vial contains 0.7 μg to 1.5 μg of bacterial genomic DNA in TE buffer (10 mM Tris-HCl, 1 mM EDTA, pH \sim 8.0). The concentration is shown on the Certificate of Analysis. The vial should be centrifuged prior to opening.

Packaging/Storage:

NR-49660 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen on dry ice and should be stored at -20°C or colder immediately upon arrival. Freeze-thaw cycles should be minimized.
