Classification: Ixodidae, *Amblyomma*

Species: *Amblyomma americanum* (common name: lone star tick)

Original Source: *Amblyomma americanum* (*A. americanum*) colony was established from adult ticks collected from vegetation in 2003 in Georgia, USA.¹

Transmission Competent Pathogens: *A. americanum* is an arthropod vector competent for transmitting the following pathogens: *Ehrlichia chaffeensis*, *Ehrlichia ewingii* and Panola Mountain ehrlichial agent.¹

Comments: This *A. americanum* colony may contain endosymbiotic *Coxiella* sp..¹ The mitochondrial genome of a representative *A. americanum* colony has been sequenced (GenBank: [NC 027609](https://www.ncbi.nlm.nih.gov/nuccore/NC_027609)).²

Material Provided:

NR-42514 contains a live, wild-type *A. americanum* adult tick. Registrants may order up to 100 (50 males and 50 females) adults. Note: *A. americanum* can also be obtained in larval (NR-44123) or nymph stages (NR-44124).

Packaging/Storage:

NR-42514 is prepared and shipped by CDC. The product is provided at room temperature and should be placed in a humidified environmental incubator³ or used immediately.

Growth Conditions:

All life stages are fed on New Zealand White rabbits. The contributor recommends standardized laboratory conditions for the maintenance of ticks.³
