Genomic DNA was extracted from a preparation of *Mycobacterium africanum* (*M. africanum*), strain NLA000017316.

M. africanum, strain NLA000017316 was isolated in March 1993 from the sputum of a human patient and was deposited to BEI Resources as an *M. africanum* West African type II strain.¹

NR-49652 has been qualified for PCR applications by amplification of approximately 1500 base pairs of the 16S ribosomal RNA gene.

Material Provided:

Each vial of NR-49652 contains 0.7 µg to 1.5 µg of bacterial genomic DNA in TE buffer (10 mM Tris-HCl, 1 mM EDTA, pH ~ 8.0). The concentration is shown on the Certificate of Analysis. The vial should be centrifuged prior to opening.

Packaging/Storage:

NR-49652 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen on dry ice and should be stored at -20°C or colder immediately upon arrival. Freeze-thaw cycles should be minimized.
