Product Description:

NR-50461 is acute plasma collected from a human subject who returned from travel to the Caribbean Islands with a confirmed Zika virus (ZIKV) infection. The sample was obtained on June 03, 2016, six days after the onset of symptoms. This case represents a primary flavivirus exposure based on virus- and type-specific neutralizing antibody titers (see Functional Activity section below).¹

Material Provided:

Each vial contains approximately 25 µL of plasma.

Packaging/Storage:

NR-50461 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. Freeze-thaw cycles should be avoided.
