Product Description:

Genomic RNA was extracted from a preparation of cell lysate and supernatant from *Cercopithecus aethiops* kidney epithelial cells (Vero E6; ATCC[®] CRL-1586™) infected with severe acute respiratory syndrome-related coronavirus 2 (SARS-CoV-2), isolate USA-CA1/2020.

SARS-CoV-2, isolate USA-CA1/2020 was isolated from a nasopharyngeal swab from a human patient in California, USA on January 23, 2020. The complete genome of SARS-CoV-2, isolate USA-CA1/2020 has been sequenced (GenBank: MN994467 and GISAID: EPI ISL 406034).

Material Provided:

Each vial contains approximately 100 µL of viral genomic RNA in TE buffer (10 mM Tris-HCl, 1 mM EDTA, pH 8.0). The viral genomic RNA is in a background of cellular nucleic acid and carrier RNA. The vial should be centrifuged prior to opening.

Packaging/Storage:

NR-52504 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen on dry ice and should be stored at -60°C or colder immediately upon arrival. Freeze-thaw cycles should be minimized.
