Description:	Full-length transmitted/founder (T/F) HIV-1 infectious molecular clones (IMC). Using a mathematical model of HIV-1 sequence evolution in acute clinical infection and an experimental strategy based on single genome amplification (SGA) of plasma vRNA/cDNA, followed by direct sequencing of uncloned SGAs, the nucleotide sequence of HIV-1 envelope (env) genes of transmitted/founder viruses have been deduced (1). Applying the same model and experimental strategy to full-length HIV-1 RNA, the complete nucleotide sequences of viruses responsible for establishing productive clinical infection have been deduced (2). The model and empirical findings indicate that a single virus (or infected cell) is responsible for clinical HIV-1 infection in ~ 80% of all cases of sexual transmission (1-4). Therefore, analysis of viruses actually responsible for transmission and productive clinical infection may be uniquely informative for HIV-1 pathogenesis and vaccine research. For this purpose, T/F single genome amplicons generated from either genomic HIV-1 RNA or proviral DNA were used to construct ten clade B T/F IMCs. An initial biological description of these IMC has been reported (2).
