Cloning Site:	EcoRI and XbaI (5'-3'). The size of the insert is approximately 1.1 kb.
Cloning Vector:	pcDNAI/amp (Invitrogen).
Description:	<p>Chemokine receptor expression vector, CCR3. The cDNA encoding CCR3 was amplified from activated PBMC RNA using primers hybridizing to the 5' and 3' untranslated regions of CCR3. The insert was digested with EcoRI and XbaI and cloned into pcDNAI/amp (Invitrogen). Constructs are selected for by adding Ampicillin (100 µg/mL) to the growth medium. Chloramphenicol (100 µg/ml) should be added 4.5–5.5 hours (OD₆₀₀ = 1.0) after seeding the culture. The plasmid can be transformed in <i>E. coli</i> strain HB101.</p> <p><u>CCR-3 primer sequences:</u> CCR-3.5'EcoRI (34mer): 5'-GACTCGAATCCTTCTTCTATCACAGGGAGAAGTG-3'. CCR-3.3'XbaI (32mer): 5'-GTGCCCTCTAGACTGGAAGTTTGAAGGACTGTT-3'.</p>
