Description:	Chemokine receptor expression vector, CCR2b.
Special Characteristics:	<p>The cDNA encoding CCR2b was amplified from activated PBMC RNA using primers hybridizing to the 5' and 3' untranslated regions of CCR2b. The PCR product was digested with BamHI and SalI and cloned into pBABE-puro. Constructs are selected for by adding Ampicillin (100µg/mL) to the growth medium. Chloramphenicol (100 µg/ml) should be added 4.5–5.5 hours (OD₆₀₀ = 1.0) after seeding the culture. The plasmid can be transformed into E. coli strain HB101.</p> <p><u>CCR-2b primer sequences:</u> CCR-2B.5'BamHI (35mer): 5'-GCTCAGGATCCTGAGACAAGCCACAAGCTGAACAG-3'.
