### Product Description:

Genomic RNA was isolated from a preparation of allantoic fluid from specific-pathogen free (SPF) embryonated chicken eggs infected with influenza A virus, A/Denver/1/1957 (H1N1).<sup>1</sup> NR-4230 is a human isolate from epidemic in Colorado, 1957 and contributed to ATCC<sup>®</sup> by Marion T. Coleman, Ph.D., World Health Organization International Influenza Center for the Americas, National Communicable Disease Center, Atlanta, Georgia, USA.

NR-4230 has been qualified for PCR applications by amplification of approximately 1000 base pairs. Recommended dilutions for successful RT-PCR amplification are indicated on the Certificate of Analysis for each lot.

#### **Material Provided:**

Each vial contains approximately  $100 \ \mu L$  of viral genomic RNA in TE buffer. The viral genomic RNA is in a background of cellular nucleic acid and carrier RNA. The vial should be centrifuged prior to opening.

#### Packaging/Storage:

NR-4230 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen on dry ice and should be stored at -60°C or colder immediately upon arrival. Freeze-thaw cycles should be minimized.
