# **Product Description:**

Genomic DNA was extracted from a preparation of *Geobacillus stearothermophilus* (*G. stearothermophilus*), strain NCA 1518 (also referred to as CIP 52.81 and NRS-T17).

G. stearothermophilus, strain NCA 1518 was isolated from under-processed canned food at the National Canners Association, Washington, D.C., USA. G. stearothermophilus, strain NCA 1518 was deposited to ATCC<sup>®</sup> in 1941 by Dr. C. P. Hegarty of Georgetown University Medical School (ATCC<sup>®</sup> 7953™). The complete genome of G. stearothermophilus, ATCC<sup>®</sup> 7953™ has been sequenced (GenBank: JALS000000000).

NR-52276 has been qualified for PCR applications by amplification of approximately 1500 base pairs of the 16S ribosomal RNA gene.

## **Material Provided:**

Each vial contains approximately 0.7  $\mu$ g to 1.5  $\mu$ g of genomic DNA in TE buffer (10 mM Tris-HCl and 1 mM EDTA, pH 8 to 8.5). The vial should be centrifuged prior to opening.

# Packaging/Storage:

NR-52278 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -20°C or colder immediately upon arrival. Freeze-thaw cycles should be minimized.
