Each vial contains approximately 1 mL of pooled allantoic fluid from specific pathogen free (SPF) embryonated chicken eggs infected with a non-L, non-H swine-like mutant (Kilbourne F2) of influenza A virus, A/duck/Alberta/35/76 (H1N1).^{1,2,3}

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

NR-3472 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Growth Conditions:

Host: 9- to 11-day-old SPF embryonated chicken eggs
 Infection: Embryonated chicken eggs must be candled to confirm viability prior to inoculation

<u>Incubation</u>: 1 to 3 days at 35°C in a humidified chamber <u>Effect</u>: Hemagglutination activity using allantoic fluid from infected embryonated chicken eggs and chicken red blood cells
