Original Source: Acinetobacter baumannii (A. baumannii), strain MRSN 960 was isolated in 2008 from a human wound sample in the USA as part of a global surveillance

program.<sup>1,2</sup>

Comments: A. baumannii, strain MRSN 960 was deposited as part of the MRSN Acinetobacter baumannii Diversity Panel available from BEI Resources as NR-52248. NR-52152 was deposited as multi-locus sequence type (MLST) ST 1, sensitive to colistin and tobramycin and resistant to amikacin, ampicillin/sulbactam, cefepime, ciprofloxacin, ceftazidime, ceftriaxone, gentamicin, imipenem, levofloxacin, meropenem, tetracycline and trimethoprim/sulfamethoxazole. Strain MRSN 960 is reported to have five aminoglycoside transferase genes [aac(3)-la, aadA1, aph(3')-la, aph(3')-Vla and aph(6)-ld; conferring resistance to various aminoglycosides], three beta-lactamase genes (blaADC-25, blaOXA-23, and blaOXA-69; conferring resistance to beta-lactams), one dihydrofolate reductase gene (dfrA1; conferring resistance to trimethoprim), two sulfonamide resistance genes (sul1 and sul2; conferring resistance to sulfonamides) and one tetracycline resistance gene [tet(B); conferring resistance to tetracycline].1 The complete genome of A. baumannii, strain MRSN 960 is available (GenBank: VHDR00000000).

A. baumannii is an aerobic, Gram-negative bacillus that exhibits the ability to rapidly develop antibiotic resistance and is a major cause of hospital-acquired infection.<sup>3</sup> The genomes of multidrug resistant strains of A. baumannii contain resistance "islands" that can contain up to 45 resistance genes. Acquisition of these antibiotic resistance genes occurs through genetic exchange of plasmids, transposons and integrons with Pseudomonas, Salmonella and Escherichia species.<sup>4,5</sup>

### **Material Provided:**

Each vial contains approximately 0.5 mL of bacterial culture in Tryptic Soy broth supplemented with 10% glycerol.

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

### Packaging/Storage:

NR-52152 was packaged aseptically in cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Nutrient broth or Tryptic Soy broth or equivalent

Nutrient agar or Tryptic Soy agar or Tryptic Soy agar with 5% defibrinated sheep blood or equivalent

Incubation:

Temperature: 37°C Atmosphere: Aerobic

Propagation:

- 1. Keep vial frozen until ready for use, then thaw.
- Transfer the entire thawed aliquot into a single tube of broth.
- Use several drops of the suspension to inoculate an agar slant and/or plate.
- 4. Incubate the tube, slant and/or plate at 37°C for 1 day.
