- <u>Original Source</u>: Acinetobacter baumannii (A. baumannii), strain MRSN 6541 was isolated in 2012 from a human wound in the United States as part of a global surveillance program.^{1,2}
- Comments: A. baumannii, strain MRSN 6541 was deposited as part of the MRSN Acinetobacter baumannii Diversity Panel available from BEI Resources as NR-52248. NR-52168 was deposited as multi-locus sequence type (MLST) ST 1, sensitive to amikacin, ceftazidime, colistin, gentamicin, tobramycin and tetracycline and resistant to levofloxacin, imipenem, ciprofloxacin, cefepime, trimethoprim/sulfamethoxazole, meropenem, and ampicillin/sulbactam with intermediate resistance to ceftriaxone. Strain MRSN 6541 is reported to have two aminoglycoside transferase genes [aadA2 and ant(2")-la; conferring resistance to various aminoglycosides], four beta-lactamase genes (blaADC-25, blacarb-2, blaOAX-25 and bla_{OXA-69}; conferring resistance to beta-lactams), a chloramphenicol acetyltransferase gene (catB3; conferring resistance to chloramphenicol), a chloramphenicol exporter gene (cmlA1; conferring resistance to chloramphenicol), a dihydrofolate reductase (dfrA19; conferring resistance to trimethoprim), a macrolide phosphotransferase [mph(E), conferring resistance to macrolides], a ABC-F type ribosomal protection protein /ABC-F subfamily protein gene [msr(E); conferring resistance to erythromycin and streptogramin B] and a sulfonamide resistance gene (sul2; conferring resistance to sulfonamides).¹ The complete genome of A. baumannii, strain MRSN 6541 is available (GenBank: VHEK0000000).

A. baumannii is an aerobic, Gram-negative bacillus that exhibits the ability to rapidly develop antibiotic resistance and is a major cause of hospital-acquired infection.³ The genomes of multidrug resistant strains of *A. baumannii* contain resistance "islands" that can contain up to 45 resistance genes. Acquisition of these antibiotic resistance genes occurs through genetic exchange of plasmids, transposons and

integrons with *Pseudomonas*, *Salmonella* and *Escherichia* species.^{4,5}

Material Provided:

Each vial contains approximately 0.5 mL of bacterial culture in Tryptic Soy broth supplemented with 10% glycerol.

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

NR-52168 was packaged aseptically in cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Propagation:

- 1. Keep vial frozen until ready for use, then thaw.
- 2. Transfer the entire thawed aliquot into a single tube of broth.
- 3. Use several drops of the suspension to inoculate an agar slant and/or plate.
- 4. Incubate the tube, slant and/or plate at 37°C for 1 day.
