#### **Product Description:**

<u>Virus Classification</u>: Coronaviridae, Betacoronavirus

<u>Species</u>: Severe acute respiratory syndrome-related coronavirus 2

Strain/Isolate: hCoV-19/USA/PHC205/2021(also referred to as hCoV-19/USA/unPHC205/2021) Please note that the lineage designation used on the product label is incorrect. The correct lineage is B.1.1.519.

<u>Original Source</u>: Severe acute respiratory syndrome-related coronavirus 2 (SARS-CoV-2), isolate hCoV-19/USA/PHC205/2021 was isolated from a nasopharyngeal swab in Memphis, Tennessee, USA on May 22, 2021.<sup>1,2</sup>

Note: Genome sequence information is provided on the Certificate of Analysis and includes an analysis of all sequence variations observed for each lot.

Comments: Under the nomenclature system introduced by GISAID (Global Initiative on Sharing All Influenza Data), SARS-CoV-2, isolate hCoV-19/USA/PHC205/2021 is assigned lineage B.1.1.519 (Pango v.3.1.15 2021-10-13) and GISAID clade GR using Phylogenetic Assignment of Named Global Outbreak lineages (PANGO) tool.<sup>2,3,4</sup> The complete genome of SARS-CoV-2, isolate hCoV-19/USA/PHC205/2021 has been sequenced (GenBank: MZ358923.1 and GISAID EPI\_ISL\_2514921).1,2 following mutations are present: Spike D614G, Spike P681H, Spike T478K, Spike T732A, N (Nucleocapsid) G204R, N Q418H, N R203K, NSP2 (Non-structural protein 2) K312R, NSP3 (Non-structural protein 3) N1329Y, NSP3 P141S, NSP3 S211N, NSP4 (Non-structural protein 4) T492I, NSP6 (Non-structural protein 6) I49V, NSP9 (Nonstructural protein 9) T35I, NSP12 (Non-structural protein 12) P323L, NSP13 (Non-structural protein 13) S236l.<sup>1,2</sup> This lineage is under monitoring by the World Health Organization (WHO), but is not assigned a variant name at this time.5

In December 2019, an outbreak of a respiratory illness (COVID-19) began in Wuhan, Hubei Province, China. The outbreak is associated with a seafood market and although

environmental samples from the market are positive for the novel coronavirus, an association with a particular animal has not been determined.<sup>5</sup> SARS-CoV-2 has been isolated from patients from several countries and the sequences of some of these isolates have been deposited with GISAID.

#### **Material Provided:**

Each vial contains approximately 0.1 mL of spin-clarified cell lysate and supernatant from *Homo sapiens* lung adenocarcinoma cells infected with SARS-CoV-2, isolate hCoV-19/USA/PHC205/2021.

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

# Packaging/Storage:

NR-55483 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

#### **Growth Conditions:**

<u>Host</u>: *Homo sapiens* lung adenocarcinoma cells (Calu-3; ATCC® HTB-55™)

Growth Medium: Eagle's Minimum Essential Medium containing Earle's Balanced Salt Solution, non-essential amino acids, 2 mM L-glutamine, 1 mM sodium pyruvate and 1500 milligrams per liter of sodium bicarbonate supplemented with 2% fetal bovine serum, or equivalent

<u>Infection</u>: Cells should be 60% to 90% confluent <u>Incubation</u>: 3 to 5 days at 37°C and 5% CO<sub>2</sub> Cytopathic Effect: Cell rounding and sloughing
