Original Source: *Klebsiella pneumoniae* (*K. pneumoniae*), strain MRSN 669510 was isolated in 2018 from a human respiratory sample in Europe as part of a global surveillance program.<sup>1</sup>

Comments: *K. pneumoniae*, strain MRSN 669510 was deposited as part of the MRSN *Klebsiella pneumoniae* Diversity Panel available from BEI Resources as NR-55604. NR-55585 was deposited as multi-locus sequence type (MLST) ST 17, K-locus type (KL) 62, O-locus type (OL) O2v2 and VIR score 0. MRSN 669510 was deposited as a multidrug-resistant (MDR) strain, sensitive to amikacin, ciprofloxacin, gentamicin, levofloxacin, tigecycline and tetracycline, intermediately resistant to aztreonam, ertapenem and tobramycin, and resistant to ampicillin/sulbactam, cefepime, ceftazidime, ceftazidime/avibactam, ceftolozane/tazobactam, ceftriaxone, imipenem, meropenem, piperacillin/tazobactam and trimethoprim/sulfamethoxazole. Strain MRSN 669510 is reported to have three aminoglycoside transferase genes [*aac*(6)-Ib4, *aadA*1 and *aph*(3'')-XV; conferring resistance to various aminoglycosides], two beta-lactamase genes (*bla*<sub>SHV-11</sub> and *bla*<sub>VIM-1</sub>; conferring resistance to beta-lactams), one chloramphenicol acetyltransferase gene (*cat*B2; conferring resistance to chloramphenicol), one fosfomycin resistance gene (*fosA*<sub>gen</sub>; conferring resistance to fosfomycin), one macrolide phosphotransferase gene [*mph*(A); conferring resistance to macrolides], one sulfonamide resistance gene (*sul*1; conferring resistance to sulfonamides) and one dihydrofolate reductase gene (*dfr*A14; conferring resistance to trimethoprim).<sup>1</sup> The complete genome of *K. pneumoniae*, strain MRSN 669510 has been sequenced (GenBank: [JAGYCA000000000](https://www.ncbi.nlm.nih.gov/nuccore/JAGYCA000000000)).

*K. pneumoniae* is a Gram-negative enterobacterium that is a major cause of nosocomial infections of the urinary and respiratory tracts. Due to the extensive spread of antibiotic-resistant strains, especially of extended-spectrum

β-lactamase (ESBL)-producing strains, there has been renewed interest in *Klebsiella* infections.<sup>2,3,4</sup>

**Material Provided:**

Each vial contains approximately 0.5 mL of bacterial culture in Tryptic Soy broth supplemented with 10% glycerol.

Note: If homogeneity is required for your intended use, please purify prior to initiating work.

**Packaging/Storage:**

NR-55585 was packaged aseptically in cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

**Growth Conditions:**

Media:

Nutrient broth or Tryptic Soy broth or equivalent  
Nutrient agar or Tryptic Soy agar or Tryptic Soy agar with 5% defibrinated sheep blood or equivalent

Incubation:

Temperature: 37°C  
Atmosphere: Aerobic

Propagation:

1. Keep vial frozen until ready for use, then thaw.
2. Transfer the entire thawed aliquot into a single tube of broth.
3. Use several drops of the suspension to inoculate an agar slant and/or plate.
4. Incubate the tube, slant and/or plate at 37°C for 1 day.
