- <u>Original Source</u>: *Klebsiella pneumoniae (K. pneumoniae)*, strain MRSN 669448 was isolated in 2017 from a blood sample in Europe as part of a global surveillance program.¹
- Comments: K. pneumoniae, strain MRSN 669448 was deposited as part of the MRSN Klebsiella pneumoniae Diversity Panel available from BEI Resources as NR-55604. NR-55584 was deposited as multi-locus sequence type (MLST) ST 307, K-locus type (KL) 102, O-locus type (OL) O2v2, VIR score 1 and versiniabactin gene allele (ybt) ybt 9; ICEKp3. MRSN 669448 was deposited as an extensively drug-resistant (XDR) strain, sensitive to amikacin and ceftazidime/avibactam, intermediately resistant to tetracycline and tigecycline, and resistant to ampicillin/sulbactam, aztreonam, cefepime, ceftazidime, ceftolozane/tazobactam, ceftriaxone, ciprofloxacin, ertapenem, gentamicin, imipenem, levofloxacin, meropenem, piperacillin/tazobactam, tobramycin and trimethoprim/sulfamethoxazole. Strain MRSN 669448 is reported to have three aminoglycoside transferase genes [aac(6')-lb-cr5, aph(3")-lb and aph(6)-ld; conferring resistance to various aminoglycosides], five beta-lactamase genes (blacTX-M-15, blaKPC-3, blaOXA-1, blaSHV-28 and blaTEM-1; conferring resistance to beta-lactams), one chloramphenicol acetyltransferase gene (catB3; conferring resistance to chloramphenicol), one fosfomycin resistance gene (fosA gen; conferring resistance to fosfomycin), one quinolone resistance gene (qnrB1; conferring resistance to quinolones), one sulfonamide resistance gene (sul2; conferring resistance to sulfonamides) and one dihydrofolate reductase gene (dfrA14; conferring resistance to trimethoprim).¹ The complete genome of K. pneumoniae, strain MRSN 669448 has been sequenced (GenBank: JAGYCB00000000).

K. pneumoniae is a Gram-negative enterobacterium that is a major cause of nosocomial infections of the urinary and respiratory tracts. Due to the extensive spread of antibiotic-resistant strains, especially of extended-spectrum

 β -lactamase (ESBL)-producing strains, there has been renewed interest in *Klebsiella* infections.^{2,3,4}

Material Provided:

Each vial contains approximately 0.5 mL of bacterial culture in Tryptic Soy broth supplemented with 10% glycerol.

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

NR-55584 was packaged aseptically in cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Growth Conditions:

Media:

Nutrient broth or Tryptic Soy broth or equivalent

Nutrient agar or Tryptic Soy agar or Tryptic Soy agar with 5% defibrinated sheep blood or equivalent

Incubation:

Temperature: 37°C

Atmosphere: Aerobic

Propagation:

- 1. Keep vial frozen until ready for use, then thaw.
- 2. Transfer the entire thawed aliquot into a single tube of broth.
- 3. Use several drops of the suspension to inoculate an agar slant and/or plate.
- 4. Incubate the tube, slant and/or plate at 37°C for 1 day.
