### **Product Description:**

- <u>Original Source</u>: *Klebsiella pneumoniae (K. pneumoniae)*, strain MRSN 27989 was isolated in 2014 from a human wound sample in North America as part of a global surveillance program.<sup>1</sup>
- K. pneumoniae, strain MRSN 27989 was Comments: deposited as part of the MRSN Klebsiella pneumoniae Diversity Panel available from BEI Resources as NR-55604. NR-55538 was deposited as multi-locus sequence type (MLST) ST 2279, K-locus type (KL) 3, O-locus type (OL) O2v2 and VIR score 0. MRSN 27989 was deposited as a multidrug-resistant strain, sensitive to amikacin. ceftazidime/avibactam, ertapenem, imipenem, meropenem, tigecycline and piperacillin/tazobactam, intermediately resistant to levofloxacin and resistant to ampicillin/sulbactam, aztreonam, cefepime, ceftazidime, ceftolozane/tazobactam, ceftriaxone, ciprofloxacin, gentamicin, tetracycline, tobramycin and trimethoprim/sulfamethoxazole. Strain MRSN 27989 is reported to have four aminoglycoside transferase genes [aac(6')-lb-cr5, aac(3)-lle, aph(3'')-lb and aph(6)-ld;conferring resistance to various aminoglycosides], four beta-lactamase genes (blaCTX-M-15, blaOXA-1, blaSHV-1 and bla<sub>TEM-1</sub>; conferring resistance to beta-lactams), one chloramphenicol acetyltransferase gene (catB3; conferring resistance to chloramphenicol), one fosfomycin resistance gene (fosA\_gen; conferring resistance to fosfomycin), one sulfonamide resistance gene (sul2; conferring resistance to sulfonamides), one tetracycline resistance gene [tet(A); conferring resistance to tetracycline] and one dihydrofolate reductase gene (dfrA14; conferring resistance to trimethoprim).<sup>1</sup> The complete genome of *K. pneumoniae*, strain MRSN 27989 has been sequenced (GenBank: JAGYDV00000000).

*K. pneumoniae* is a Gram-negative enterobacterium that is a major cause of nosocomial infections of the urinary and respiratory tracts. Due to the extensive spread of antibiotic-resistant strains, especially of extended-spectrum  $\beta$ -lactamase (ESBL)-producing strains, there has been renewed interest in *Klebsiella* infections.<sup>2,3,4</sup>

# Material Provided:

Each vial contains approximately 0.5 mL of bacterial culture in Tryptic Soy broth supplemented with 10% glycerol.

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

## Packaging/Storage:

NR-55538 was packaged aseptically in cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

# Growth Conditions:

#### Media:

Nutrient broth or Tryptic Soy broth or equivalent

Nutrient agar or Tryptic Soy agar or Tryptic Soy agar with 5% defibrinated sheep blood or equivalent

Incubation:

Temperature: 37°C

Atmosphere: Aerobic

Propagation:

- 1. Keep vial frozen until ready for use, then thaw.
- 2. Transfer the entire thawed aliquot into a single tube of broth.
- 3. Use several drops of the suspension to inoculate an agar slant and/or plate.
- 4. Incubate the tube, slant and/or plate at 37°C for 1 day.
