### **Product Description:**

Original Source: Klebsiella pneumoniae (K. pneumoniae), strain MRSN 13761 was isolated in 2011 from a human wound sample in Europe as part of a global surveillance program.<sup>1</sup>

Comments: K. pneumoniae, strain MRSN 13761 was deposited as part of the MRSN Klebsiella pneumoniae Diversity Panel available from BEI Resources as NR-55604. NR-55516 was deposited as multi-locus sequence type (MLST) ST 394, K-locus type (KL) 3, O-locus type (OL) O2v2 and VIR score 0. MRSN 13761 was deposited as an extensively drug-resistant strain, sensitive to amikacin, ceftazidime/avibactam and tigecycline, intermediately resistant to aztreonam, ceftazidime and levofloxacin and resistant to ampicillin/sulbactam, cefepime, ceftolozane/tazobactam, ceftriaxone, ciprofloxacin, gentamicin, imipenem, meropenem, ertapenem, piperacillin/tazobactam, tetracycline, tobramycin and trimethoprim/sulfamethoxazole. Strain MRSN 13761 is reported to have four aminoglycoside transferase genes [aac(3)-lle, aac(6')-lb-cr5, aph(3'')-lb and aph(6)-ld; conferring resistance to various aminoglycosides], five betalactamase genes (blactx-M-15, blaoxa-1, blaoxa-48, blashv-11 and blaTEM-1; conferring resistance to beta-lactams), one fosfomycin resistance gene (fosA\_gen; conferring resistance to fosfomycin), one quinolone resistance gene (qnrB1; conferring resistance to quinolones), one sulfonamide resistance gene (sul2; conferring resistance to sulfonamides), one tetracycline resistance gene [tet(A); conferring resistance to tetracycline] and one dihydrofolate reductase gene (*dfr*A14; conferring resistance to trimethoprim).<sup>1</sup> The complete genome of *K. pneumoniae*, strain MRSN 13761 has been sequenced (GenBank: JAGYEQ000000000).

K. pneumoniae is a Gram-negative enterobacterium that is a major cause of nosocomial infections of the urinary and respiratory tracts. Due to the extensive spread of antibiotic-resistant strains, especially of extended-spectrum β-lactamase (ESBL)-producing strains, there has been renewed interest in Klebsiella infections.<sup>2,3,4</sup>

#### **Material Provided:**

Each vial contains approximately 0.5 mL of bacterial culture in Tryptic Soy broth supplemented with 10% glycerol.

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

### Packaging/Storage:

NR-55516 was packaged aseptically in cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

#### **Growth Conditions:**

Media:

Nutrient broth or Tryptic Soy broth or equivalent

Nutrient agar or Tryptic Soy agar or Tryptic Soy agar with 5% defibrinated sheep blood or equivalent

Incubation:

Temperature: 37°C Atmosphere: Aerobic

Propagation:

- 1. Keep vial frozen until ready for use, then thaw.
- 2. Transfer the entire thawed aliquot into a single tube of broth.
- 3. Use several drops of the suspension to inoculate an agar slant and/or plate.
- 4. Incubate the tube, slant and/or plate at 37°C for 1 day.
