Original Source: *Klebsiella pneumoniae* (*K. pneumoniae*), strain MRSN 13748 was isolated in 2011 from a human blood sample in Europe as part of a global surveillance program.<sup>1</sup>

Comments: *K. pneumoniae*, strain MRSN 13748 was deposited as part of the MRSN *Klebsiella pneumoniae* Diversity Panel available from BEI Resources as NR-55604. NR-55515 was deposited as multi-locus sequence type (MLST) ST 107, K-locus type (KL) 10, O-locus type (OL) O1v1 and VIR score 1. MRSN 13748 was deposited as an extensively drug-resistant strain, sensitive to amikacin and ceftazidime/avibactam, intermediately resistant to ceftazidime and tobramycin and resistant to ampicillin/sulbactam, aztreonam, cefepime, ceftolozane/tazobactam, ceftriaxone, ciprofloxacin, ertapenem, gentamicin, imipenem, levofloxacin, meropenem, piperacillin/tazobactam, tetracycline, tigecycline and trimethoprim/sulfamethoxazole. Strain MRSN 13748 is reported to have three aminoglycoside transferase genes [*aac*(3)-IId, *aph*(3)-Ib and *aph*(6)-Id; conferring resistance to aminoglycosides], four beta-lactamase genes (*bla*<sub>CTX-M-14</sub>, *bla*<sub>OXA-48</sub>, *bla*<sub>SHV-11</sub> and *bla*<sub>TEM-1</sub>; conferring resistance to beta-lactams), one fosfomycin resistance gene (*fosA*<sub>gen</sub>; conferring resistance to fosfomycin), one quinolone resistance gene (*qnrS*1; conferring resistance to quinolones), two sulfonamide resistance genes (*sul*1 and *sul*2; conferring resistance to sulfonamides), two tetracycline resistance genes [*tet*(A) and *tet*(D); conferring resistance to tetracycline] and one dihydrofolate reductase gene (*dhfr*A1; conferring resistance to trimethoprim).<sup>1</sup> The complete genome of *K. pneumoniae*, strain MRSN 13748 has been sequenced (GenBank: [JAGYER000000000](https://www.ncbi.nlm.nih.gov/nuccore/JAGYER000000000)).

*K. pneumoniae* is a Gram-negative enterobacterium that is a major cause of nosocomial infections of the urinary and respiratory tracts. Due to the extensive spread of antibiotic-resistant strains, especially of extended-spectrum β-lactamase (ESBL)-producing strains, there has been renewed interest in *Klebsiella* infections.<sup>2,3,4</sup>

**Material Provided:**

Each vial contains approximately 0.5 mL of bacterial culture in Tryptic Soy broth supplemented with 10% glycerol.

Note: If homogeneity is required for your intended use, please purify prior to initiating work.

**Packaging/Storage:**

NR-55515 was packaged aseptically in cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

**Growth Conditions:**

Media:

Nutrient broth or Tryptic Soy broth or equivalent  
Nutrient agar or Tryptic Soy agar or Tryptic Soy agar with 5% defibrinated sheep blood or equivalent

Incubation:

Temperature: 37°C  
Atmosphere: Aerobic

Propagation:

1. Keep vial frozen until ready for use, then thaw.
2. Transfer the entire thawed aliquot into a single tube of broth.
3. Use several drops of the suspension to inoculate an agar slant and/or plate.
4. Incubate the tube, slant and/or plate at 37°C for 1 day.
