Genomic DNA was isolated from a preparation of cell lysate and supernatant from *Cercopithecus aethiops* kidney epithelial cells (BSC-40; ATCC® CRL-2761™) infected with monkeypox virus (MPXV), hMPXV/USA/MA001/2022 (Lineage B.1, Clade IIb).

NR-58710 has been qualified for PCR applications by amplification of an approximately 1000 base pairs amplicon of the HA gene. Recommended dilutions for successful PCR amplification are indicated on the Certificate of Analysis for each lot.

#### **Material Provided:**

Each vial contains approximately 100 µL of genomic DNA prepared in TE buffer (10 mM Tris-HCI, 1 mM EDTA). The vial should be centrifuged prior to opening.

#### Packaging/Storage:

NR-58710 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen on dry ice and should be stored at -20°C or colder immediately upon arrival. Freeze-thaw cycles should be minimized.
