Each vial contains approximately 1 mL of cell lysate and supernatant from Madin-Darby Canine Kidney (MDCK) cells (ATCC[®] CCL-34[™]) infected with Influenza A virus, A/Netherlands/2629/2009 (H1N1)pdm09.

Packaging/Storage:

NR-19823 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.
