## **Product Description:**

Antibody Class: IgG1κ

Mouse monoclonal antibody prepared against a recombinant form of the mink interferon alpha (IFN- $\alpha$ ) protein was purified from clone P1C3F3 supernatant by protein G affinity chromatography. The B cell hybridoma was generated by the fusion of Sp2/0-Ag14 myeloma cells with splenocytes from a BALB/c mouse immunized with recombinant mink IFN- $\alpha$  protein (BEI Resources NR-43943, lot 61896920).

#### **Material Provided:**

Each vial of NR-48628 contains approximately 100  $\mu$ L of purified monoclonal antibody in PBS. The concentration, expressed as milligrams per milliliter, is shown on the Certificate of Analysis.

#### Packaging/Storage:

This product was packaged aseptically in screw-capped plastic vials and is provided frozen on dry ice. The product should be stored at -20°C or colder immediately upon arrival. Freeze-thaw cycles should be avoided.

#### **Functional Activity:**

NR-48628 recognizes recombinant mink IFN- $\alpha$  in western blot assays. See Certificate of Analysis for details.
