Product Description:

Complementary DNA (cDNA) was synthesized from RNA extracted from *Schistosoma mansoni* (*S. mansoni*), strain NMRI, cercariae.

S. mansoni, strain NMRI was isolated in the 1940s from infected Puerto Rican school children.¹ S. mansoni is a species of trematode worm which causes the chronic parasitic disease Schistosomiasis.

Material Provided:

Each vial contains a variable amount of cDNA in DNase/RNase-free distilled water. The concentration is shown on the Certificate of Analysis. The vial should be centrifuged prior to opening.

Packaging/Storage:

NR-49423 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -20°C or colder upon arrival. Freeze-thaw cycles should be minimized.
