<u>Original Source</u>: Klebsiella pneumoniae (K. pneumoniae), strain MRSN 5613 was isolated in 2011 from a human urine sample in North America as part of a global surveillance program.¹

Comments: K. pneumoniae, strain MRSN 5613 was deposited as part of the MRSN Klebsiella pneumoniae Diversity Panel available from BEI Resources as NR-55604. NR-55508 was deposited as multi-locus sequence type (MLST) ST 1787, K-locus type (KL) 148, O-locus type (OL) O1v2 and VIR score 0. MRSN 5613 was deposited as an extensively drug-resistant strain, sensitive to amikacin, ceftazidime/avibactam, ertapenem, imipenem, meropenem and tigecycline, intermediately resistant to ciprofloxacin, levofloxacin and piperacillin/tazobactam and resistant to ampicillin/sulbactam, aztreonam, cefepime, ceftazidime, ceftolozane/tazobactam, ceftriaxone, gentamicin, trimethoprim/sulfamethoxazole tetracycline, and tobramycin. Strain MRSN 5613 is reported to have four aminoglycoside transferase [aac(3)-lle, genes aac(6')-lb-cr5, aph(3'')-lb and aph(6)-ld; conferring resistance to various aminoglycosides], four beta-lactamase genes (blactx-M-15, blacxA-1, blashy-11 and blatem-1; conferring resistance to beta-lactams), two chloramphenicol acetyltransferase genes (catA2 and catB3; conferring resistance to chloramphenicol), one fosfomycin resistance gene (fosA_gen; conferring resistance to fosfomycin), one quinolone resistance gene (qnrB1; conferring resistance to quinolones), one sulfonamide resistance gene (sul2; conferring resistance to sulfonamides), one tetracycline resistance gene [tet(A); conferring resistance to tetracycline] and one dihydrofolate reductase gene (dfrA14; conferring resistance to trimethoprim).¹ The complete genome of K. pneumoniae, strain MRSN 5613 has been sequenced (GenBank: JAGYEY000000000).

K. pneumoniae is a Gram-negative enterobacterium that is a major cause of nosocomial infections of the urinary and respiratory tracts. Due to the extensive spread of antibiotic-resistant strains, especially of extended-spectrum

 β -lactamase (ESBL)-producing strains, there has been renewed interest in *Klebsiella* infections. $^{2.3.4}$

Material Provided:

Each vial contains approximately 0.5 mL of bacterial culture in Tryptic Soy broth supplemented with 10% glycerol.

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

NR-55508 was packaged aseptically in cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Growth Conditions:

Media:

Nutrient broth or Tryptic Soy broth or equivalent

Nutrient agar or Tryptic Soy agar or Tryptic Soy agar with 5% defibrinated sheep blood or equivalent

Incubation:

Temperature: 37°C Atmosphere: Aerobic

Propagation:

- 1. Keep vial frozen until ready for use, then thaw.
- 2. Transfer the entire thawed aliquot into a single tube of broth.
- 3. Use several drops of the suspension to inoculate an agar slant and/or plate.
- 4. Incubate the tube, slant and/or plate at 37°C for 1 day.
