Product Description: Clostridium difficile (C. difficile; also referred to as Peptoclostridium difficile), isolate 20110742 was obtained from the stool of a pediatric male patient with a community-associated (CA) C. difficile infection in northeastern USA in 2011. Isolate 20110742 was deposited as PCR ribotype 002, North American pulsed-field gel electrophoresis type 6 (NAP6), containing tcdA, tcdB and tcdC of the PaLoc operon. This isolate is reported to be negative for the C. difficile binary toxin (CDT).

¹NR-49305 was produced by inoculation of the deposited material into Modified Reinforced Clostridial medium and incubated for 2 days at 37°C in an anaerobic atmosphere (< 0.5% O₂; Remel™ Anaero Pack-Anaero™ R681001). The material from the initial growth was passaged in Modified Reinforced Clostridial medium for 1 day at 37°C in an anaerobic atmosphere to produce this lot.


