<sup>10</sup>For streptomycin, ethionamide, para-aminosalicylic acid, rifabutin and ethambutol, the endpoint for these drugs is determined by the well with approximately 80% inhibition of growth compared to the positive control well with no drug.

12Two MICs were observed for moxifloxacin (0.12 μg/mL and 0.25 μg/mL) under identical test conditions. The highest MIC is being reported as the test result.


