Staphylococcus aureus subsp. aureus, Strain JE2, Transposon Mutant NE1396 (SAUSA300 0038)

**Product Description:** Staphylococcus aureus (S. aureus) subsp. aureus, transposon mutant NE1396 was derived from S. aureus subsp. aureus, strain JE2. Mutagenesis occurred through the use of the mariner-based transposon bursa aurealis resulting in an erythromycin-resistant deletion strain of JE2. S. aureus subsp. aureus, transposon mutant NE1396 was created by disruption of ccrA, which encodes for a cassette chromosome recombinase A that is involved in chromosomal excision and integration of the SCCmec cassette. Strain JE2 is a plasmid-cured derivative of strain LAC that was isolated in 2002 from a skin and soft tissue infection of an inmate in the Los Angeles County Jail in California, USA.

Broth inoculum was added to Tryptic Soy agar with 5 μg/mL erythromycin kolles, which were grown 1 day at 37°C in an aerobic atmosphere to produce this lot.

Gene specific primers should be paired with either the "Upstream" primer (5'-CTCGATTCTATTAACAAGGG-3') for transposons in the "plus" orientation or the "Buster" primer (5'-GCTTTTTCTAAATGTTTTTTAAGTAAATCAAGTAC-3') for transposons in the "minus" orientation.
