<sup>1</sup>NR-30873 was produced by inoculation of the deposited material into Middlebrook 7H9 broth with ADC enrichment. Broth inoculum was added to Middlebrook 7H10 agar with OADC enrichment kolles, which were grown for 46 days at 37°C in an aerobic atmosphere with 5% CO<sub>2</sub>. The resulting growth was harvested in Middlebrook 7H9 broth with ADC enrichment supplemented with 10% glycerol and frozen. The frozen material was later thawed and aliquoted into cryovials and frozen to produce this lot.
