Staphylococcus aureus (S. aureus) subsp. aureus, transposon mutant NE358 was derived from S. aureus subsp. aureus, strain JE2. Mutagenesis occurred through the use of the *mariner*-based transposon *bursa aurealis* resulting in an erythromycin-resistant deletion strain of JE2. S. aureus subsp. aureus, transposon mutant NE358 was created by disruption of SAUSA300_0294, which encodes for a hypothetical protein. NR-46901 lot 70055501 was produced by inoculation of the deposited material into Tryptic Soy broth with 5 μ g per mL erythromycin and incubated for 1 day at 37°C in an aerobic atmosphere. Broth inoculum was added to Tryptic Soy agar with 5 μ g per mL erythromycin kolles, which were grown 1 day at 37°C in an aerobic atmosphere to produce this lot. Quality control testing was completed under propagation conditions unless otherwise noted.

<u>Note</u>: Prior to initiating work, it is recommended that the presence and location of the transposon is confirmed. Gene specific primers should be paired with either the "Upstream" primer (5'-CTCGATTCTATTAACAAGGG-3') for transposons in the "plus" orientation or the "Buster" primer (5'-GCTTTTTCTAAATGTTTTTAAGTAAATCAAGTAC-3') for transposons in the "minus" orientation. 
